Tuesday, June 7, 2022

8:30 – 9:30 Opening Worship with Holy Communion

Preacher: Dr. Ken Cherney, Wis. Luth. Sem., Sermon Text: Job 13:1-16. Dr. Cherney shared that although we may suffer, we will hope in Him. I know

9:50 – 10:05 Welcome by District President, each person introduced themselves.

Housekeeping announcements shared by the District President and

District Secretary.

10:05 – 10:35 District President's Report, Pastor John Steinbrenner. Report includes a

well-written and meaningful devotion, all official acts of the PNW including called workers into the district, all called workers out of the

district, church and school openings and closings, resignations,

retirements, and one suspension. The report also included WELS notes regarding vacancies, recruitment, studies on the divine call as well as the role of man and woman, CMO, child abuse protection policies, Synod code, Circuit pastors, Sem Satellite Courses, and special thanks. There were no

questions.

10:35 – 10:45 Nominating Committee Chairman, Pastor Luke Tembreull: Elections. Luke

explained that we have 19 elections to complete. Luke explained that he would accept nominations for District President via texting and gave his cell number. **John Steinbrenner was nominated, Craig Wasser refused**

nomination. Bart Brauer accepted nomination, Dan Kramer accepted nomination and Kevin Schultz refused nomination.

Synodical Council Report, PNW Representative, Mr. Brent Masters. Lay Representative and Secretary for the Administration Committee. Serves as councilman at Cross of Christ in Boise, ID. Brent explained who makes up the SC and the work of the SC. Brent highlighted the finances of the WELS, including CMO, the Financial Stabilization Fund, PPP loans, inflation and wages. Pastor Wetzel asked if there are any highlights from the other two committees of the SC (Ministry and Finance Committee). Brent responded with some information about the pension discussions that have been taking place.
